This is the inaugural multi-discipline Canadian Nationals Championships for rifle, shotgun and pistol sections to be held in Cookstown at the new Pan American range. ARTICLE 1
GENERAL INFORMATION FOR ALL DISCIPLINES

1.1 Registration

REGISTRATION WILL BE BASED ON FIRST COME, FIRST SERVED AND NO REGISTRATION WILL BE ACCEPTED WITHOUT PAYMENT IN FULL AT TIME OF REGISTRATION. All international competitors will have their Letter of Invitation generated after payment has been received.

You may pay by credit card using the online system. You will receive a confirmation email with instructions for payment based on the payment method selected. Payment must be received before your registration and squadding can be confirmed. Registration and/or payment by cheque or money order can also be sent via regular post or courier to the SFC Head Office using the appropriate registration form attached hereto, but must be received no later than July 20, 2017. Make all cheques payable to: Shooting Federation of Canada re: National Championships. The \$25 compulsory SFC Administration/Nationals Operation Fee is non-refundable.

Post-competition entries will be accepted only if space is available and are subject to a Late Registration Fee of \$50 for all disciplines and on-site entries must be paid for in cash only. All rifle and pistol shooters must register a minimum of one day prior to the start of the first relay of the event that they wish to compete in. There will be no registrations taken once the event has commenced.

NOTE: ALL PARTICIPANTS MUST COMPLETE AND SIGN A WAIVER FORM AND SUBMIT IT TO THE REGISTRATION DESK PRIOR TO COMPETITION

1.3 Shooting Facilities

The Pan Am Range has 40 covered rifle/pistol positions at either 25 or 50 meters and the space can also be safely divided between the two distances. The Air rifle/pistol range has 50 positions located above the 25/50m range. All targets are Megalink Electronic system. Parking at the range is very plentiful but

please only park in designated areas and not on the grass. All ranges are accessible for wheelchairs and mobility devices. All major hotels/motels are approximately a 20 minute drive from the range.

Range Equipment – Please bring all your own equipment including, shooting mat, scope stand, extensions, stapler, stool or chair, in other words, EVERYTHING. If you do not wish to bring your own mat, the Pan Am mats will be available.

1.6 Food

The TTS Clubhouse food service will be available generally throughout the competition which is on site and provides a healthful, reasonably priced menu that directly supports the range. 1.7 SFC Membership

All competitors must be current members of the Shooting Federation of Canada. This will be verified by the SFC National Office prior to the match. Everyone (including those who do not pre-register) must be able to provide proof of membership or must purchase a membership at the time of registration. SFC membership is not required of Americans with current 2017 NRA/USA Shooting memberships.

Note: Those who are not Canadian citizens must show proof of Canadian covered insurance or purchase an SFC membership with insurance included.

 Juniors (under 18 years of age) \$15.00 incl. HST.

1.8 Classifications

Shooting Federation of Canada (SFC) members with a current, valid classification will compete in their respective class. USA competitors with a current, valid classification card will be placed in the equivalent SFC classification. All others will compete in the Temporary Expert Class – or Veteran, International Junior or Sub-junior if they qualify. Please also refer to specific classification rules in each section. Clay Target participants will be classified at the venue.

All competitors are asked to register according to their true classification. This will be verified by the SFC National Office prior to the match. However, everyone must have proof of their classifications available at registration. This will be required of all shooters who do not pre-register.

The Jury has the right to correct obvious mistakes.

Anyone not having a current SFC classification shall shoot as a Temporary Expert. This applies to NRA members as well, as NRA classifications will not be accepted.

After shooting in one SFC match (1 full course) however, an American shooter will be assigned an SFC classification (at no charge) based on his/her scores in that match. He/She must use that classification in all subsequent SFC matches, or until he/she is reclassified, the same way as any SFC shooter.

1.9 2018 High Performance Athlete Selection Criteria

To be eligible for the 2018 National Team you must attend the 2017 Canadian National Championships. Please see the SFC website for current information relevant to High Performance Athletes under Selection Criteria at the following link: http://sfc-ftc.ca/en/the_sfc/selection_criteria.html

Attendance at the Canadian National Championships is mandatory for national team consideration and athletes not already on national teams must submit a list of potential competitions to the SFC Technical Director prior to the start of the first scheduled event using the published HPC Match Designation Form.

1.10 Rules

The current Jan. 1/2017 ISSF rules including subsequent amendments, interpretations and errata from the ISSF website will apply to all ISSF events in all disciplines. It is the responsibility of the athlete and coaches to be familiar with the current ISSF rules.

Sporting Rifle will be governed by the current SFC Sporting Rifle Rules.

Hunting Rifle rules will be those as in the past written by Red Bowes and updated by Robert Wood.

1.13 Match Start Times

Please note that the times on the schedule are the times for the first SCORING shot in ISSF events (pursuant to Rule 7.9). Preparation and Sighting time will commence 15 minutes earlier than the published start time except for Sporting/Hunting Rifle where the start time listed is the first sighting shot time.

Shotgun events will commence at the call of the Chief Range Official.

As with all events, circumstances may cause delays. Event's will not start earlier than the time posted but may start later

1.14 Special Notice from Match Committee regarding Rifle and Pistol Events

In the event that a competitor's fired shots hit the electronic scoring target protection plate, the following penalty sequence shall be followed:

First Occurrence: Yellow Card...Warning

Second Occurrence: Green Card...2 point penalty

Third Occurrence: Red Card...disqualification due to unsafe shooting practices.

The score that has been fired for record will be entered into the record sheets. No refund will be offered to the competitor.

1.15 Safety

All pertinent firearms safety practices will be observed. Failure to follow safety rules or direction from Range Officers or Range Jury may be cause for disqualification and/or removal.

Eye protection is recommended for all competitors and officials on ranges while shooting is in progress. Any medical emergencies should be immediately reported to a range official.

The Organizing Committee and the Shooting Federation of Canada will not be responsible for any articles lost or stolen or any article left at the range during the competition.

No uncased rifle or pistol firearms or air guns may be transported outside of the shooting range.

1.16 Permits for International Competitors

Visitors to Canada who are bringing an air pistol or air rifle that has a muzzle velocity of less than 500 feet per second do not require permits.

Attention 'International' competitors:

Please be aware, we DO NOT use any outside agents to sell registrations and/or VISAs to this event. If someone is offering this service then it is an act of fraud which should be reported and we are in no way associated with such actions. Register ONLY directly with us. Each competitor is responsible for applying and obtaining any necessary travel VISAs and/or equipment applications for entry into Canada and unfortunately we are NOT able to assist in this process in any way.

1.17 Air Rifle/Pistol Propellant

Compressed air will be available for filling of rifle and pistol cylinders, but competitors must provide their own tank/cylinder adapters. If you require CO2 gas, you must provide your own.

1.18 Smoking

Smoking is not permitted in any range, stats or scoring offices, any other closed room or tent, OR on any of the firing lines. Kindly go beyond the parking lot area and away from the on-site propane tank if you must smoke or vape.

1.19 Anti-doping Controls

Anti-doping controls may be conducted by the Canadian Centre for Drug-free Sport in accordance with ISSF and International Olympic Committee anti-doping regulations.

1.20 Juries and Officials

Specific juries and officials information will be posted on the range(s), as applicable.

1.21 Competition Results

Competition results will be posted on the SFC Website as soon as they are available and sent to all participants by e-mail after the conclusion of the entire event, if and when possible.

1.22 Dress Code

All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Dress Code policy as attached hereto as Exhibit I. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director, the Chief Range Officer and/or the relevant Section Chair.

1.23 Code Of Ethics

All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Code of Ethics policy as attached hereto as Exhibit II. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director, the Chief Range Officer and/or the Pistol Section Chair.

Behavior issues: Please be aware that the Organizing Committee will not tolerate any abuse of any kind of our volunteers, officials or competitors. If the organizing committee determines that such abuse has occurred or that the ISSF Code of Ethics has been breached, the organizing committee will eject any individual responsible for such abuse. The individual may be ejected from any venue utilized by the National Championship.

2.2 **Rules and Regulations**

The 2017 Canadian International Trapshooting Championships will be conducted according to the ISSF Rules and Regulations, Edition (2013 Edition 3rd print 01/2015). Detailed information is available on the ISSF website at www.issf-sports.org.

The Jury reserves the right to make exceptions to the Rules, procedures and times as and when necessary. All changes will be announced in writing and posted at the range clubhouse.

The Chief Range Officer (Equipment Control, Classification and Appeals) are designated by the Shotgun Section to supervise the 2017 Canadian International Trapshooting Championships, and major officials will hold a valid ISSF Shotgun A or B level referee or judge license.

The Chief Range Officer will coordinate with the match director to select an appropriate number of jury members. Selected jury members should be familiar with the ISSF shooting rules and be an experienced athlete, official and/or competition staff.

The Chief Range Officer will also verify with the match staff that the targets and computers used for the competition are in working order and that the targets are set according to the ISSF Rules and Regulations.

All shooters are expected to serve as sideline referees. If scheduled for the next round, there will be at least a 20 minute break between flanking and shooting. If an athlete fails to act as a sideline referee when he/she is required to do so, they shall be penalized as per the ISSF Rules.

An up-to-date program schedule (with changes to time or added information) will be posted in the clubhouse prior to the match.

Equipment control, if conducted, will be conducted according to the ISSF Rules and Regulation (9.4.1) using approved instruments.

Targets: The shooting range for Trap/Double Trap is equipped with International orange targets (Lawry/White Flyer) for qualification and finals.

Protests: Warnings/penalties will be given according to the current ISSF Official Statutes, Rules and Regulations. Protest forms will be available in the entry office.

Protests will be handled by the Jury. Cost is \$25.00 each. The Jury's decisions are **final**.

2.4 Finals

Semi-final and medal match in Trap and Double Trap will be shot according to the current ISSF Rules and Regulations format, with the following exception:

Exception: Scores from the qualification rounds will be added to the scores in the semi-final round to determine which athletes will compete in the medal round.

The top 6 Canadian shooters in all Trap and Double Trap events (including juniors) will be invited to participate in the semi-final and medal matches.

Only Canadian citizens will be eligible for the semi-final and medal matches.

The top 2 shooters from the semi-finals will advance to the gold medal match in each event. The third- and fourth-place athletes from the semi-finals will advance to the bronze medal match in each event.

Scores in the medal round will start at zero (0). No previous scores will carry over to the medal round.

The National Champion in each ISSF event will be determined by the results of the Gold Medal Match (final).

A junior may not be excluded from a final in any event from which he/she has qualified.

2.5 Awards

Only one (1) trophy per event can be awarded. In a situation where an athlete qualifies for more than one (1) award, the highest placing will be awarded to the athlete.

For example: A junior who places runner-up in a junior event may not receive this award if they win the senior final.

All awards will be presented by CIT after the competition has concluded.

2.6 Entry Process

You are encouraged to use the on-line registration process available at the SFC website. If you do not have internet access, a paper entry form is attached as Appendix 1.

Registration will be in the clubhouse, on the days and at the times noted in the Schedule of Events attached as Schedule B. Please register on the days set aside for this purpose.

Each event will be conducted using two (2) bunkers for trap and one or two for double trap.

Registration will be limited to a maximum of sixty (60) competitors for all Single Trap events, and sixty (60) competitors for all Double Trap events.

Priority and preference shall be given to those athletes who competed in the 2016 Canadian International Trapshooting Championships and/or are Canadian citizens.

2.7 Membership

All competitors must be 2017 members of the Shooting Federation of Canada. Membership will be verified by the SFC National Office prior to the match.

Every participant must be able to provide proof of membership at registration.

SFC membership is not required of Americans with current 2017 USA Shooting memberships.

Note: Those who are not Canadian citizens must show proof of Canadian-covered insurance, or purchase an SFC membership with insurance included.

3.2 Rules and Regulations

The 2017 Canadian International Skeet Shooting Championships will be conducted according to the ISSF Rules and Regulation Edition (January 1/2017). Detailed information is available on the ISSF website www.issf-sports.org. The Jury reserves the right to make exceptions to the Rules as and when necessary. All changes will be announced in writing and posted at the range clubhouse.

The Chief Range Officer (Equipment Control, Classification and Appeals) are designated by the Shotgun Section to supervise the 2017 Canadian International Skeet Shooting Championships and major officials will hold a valid ISSF Shotgun A or B level referee or judge license.

The Chief Range Officer will coordinate with the match director to select an appropriate number of jury members. Selected jury members should be familiar with the ISSF shooting rules and be an experienced athlete, official and/or competition staff.

The Chief Range Officer will also verify with the match staff that the targets and computers used for the competition are in working order and that the targets are set according to the ISSF Rules and Regulations.

All shooters are expected to serve as sideline referees. If scheduled for the next round, there will be a 10 minute break between flanking and shooting. If an athlete fails to act as a sideline referee when he/she is required to do so, they shall be penalized as per ISSF Rules.

An up to date program schedule (with changes to time or added information) will be posted in the clubhouse prior to the match.

Equipment control will be conducted according to the ISSF Rules and Regulation (9.4.1) using approved instruments.

Targets: ISSF approved International orange targets will be supplied for qualification and finals.

Protests: Warnings/penalties will be given according to current ISSF Official Statutes, Rules and Regulations. Protest forms will be available.

Protests will be handled by the Jury. Cost is \$25.00 each.

Jury decisions are **final**.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

Non-medical use of drugs, or consumption of alcohol is not permitted anywhere on range property. Random doping tests for any competitor are possible at any time. Please see the SFC website for SFC Policy on Doping in Sport.

Canadian Centre for Ethics in Sport (CCES) may conduct anti-doping testing and controls at these Championships. Participation in this competition constitutes a willingness to undergo testing if selected. (Reference I.S.S.F. Anti-Doping Rules item 5.6.5)

3.4 Finals

Semi-final and medal match in Skeet will be shot according to the 2017 ISSF Rules and Regulations.

Top 6 Canadian shooters in all Skeet events (including Women and juniors) will be invited to participate in semi-final and applicable medal matches.

Only Canadian citizens will be eligible for semi-final and medal matches.

Qualification scores will be added to semi-final scores to determine which athletes will compete in medal matches.

Top 2 shooters from semi-finals will advance to gold medal match. Third and fourth place shooters from semi-finals will advance to bronze medal match.

*Medal round scores will be added to cumulative score from both qualification and semi-final rounds

e.g. National Champion will be selected from shooters competing in Gold Medal Match, and based on cumulative score from all targets shot (Qualification, Semi-final, and Gold Medal Match)

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

3.5 Awards

Awards will be presented by the Skeet Association after the competition has concluded.

3.6 Entry Process

Please fill out the online registration form. If you do not have internet access, a paper entry form is attached as Appendix 2.

Priority and preference shall be given to athletes who competed in the 2016 Canadian International Skeet Shooting Championships and/or are Canadian citizens.

Registration will be in the clubhouse on days and times noted in Schedule of Events.

3.7 Annual Section Meeting

The C.I.S.S.A. Annual Section Meeting will be held during the match on Wednesday, August 2, 2017 in the TTS Clubhouse. **Meeting time will be posted prior to the start of that day's events.**

4.2 **Rules and Regulations**

The 2017 Canadian National Smallbore Rifle Championships will be conducted according to the ISSF Rules and Regulation Edition (January 1/2017). Detailed information is available on the ISSF website www.issf-sports.org.

Should for any reason the ISSF rules not be followed, the Jury will post the changes in the clubhouse.

Sporting Rifle will be governed by the current SFC Sporting Rifle Rules. Hunting Rifle rules will be those as in the past written by Red Bowes and updated by Robert Wood.

Exception: ISSF 3 Position only. TIE-BREAKING “Rule 6.15.1” The highest number of inner tens.

Juries (Equipment Control, Classification and Appeals) are designated by the Rifle Section to supervise the 2017 Canadian National Smallbore Rifle Championships. Qualified Range Officers holding applicable licenses will conduct the competitions.

Regarding the use of only air or CO2 cylinders please refer to ISSF Rule 6.2.4.2. of the rule book which states the following:

It is the athletes responsibility that any air or CO2 cylinder is still within its validity date. This may be checked by Equipment Control.

Protests will be handled by the Jury. Cost is \$25.00 each.

The Jury’s decisions are **final**.

4.3 **Event Summaries**

INDIVIDUAL EVENTS

Sporting Rifle & Hunting Rifle

Prone – 2 courses of 60 shots per course = 120

3P – 2 courses of 20 shots per position = 120

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

ISSF Air Rifle

10 meters standing (except Adaptive Shooting) – 1 shot per target.

Men & Junior Men – 2 courses of 60 shots per course.

Women & Junior Women – 2 courses of 40 shots per course.

Adaptive Shooting – 2 courses of 60 shots: 1 prone, 1 standing.

Women & Junior Women match will not be shot concurrently with the Men's event.

Women & Junior Women may not register to shoot for OPEN awards. Juniors (women or men) must pay the adult fee to be eligible for Class awards.

Air Rifle squadding will be assigned and posted at the range in advance of competition.

ISSF Men 3 Position

Unlimited sighting shots on sighting diagrams.

1 scoring diagram per record target, 2 shots per scoring diagram prone, 5 shots per scoring diagram standing & kneeling.

Squadding for relays will be random.

Men and Women 3 Position are fired simultaneously – total entry in the matches is limited to 35 positions.

Adaptive shooters will compete in their appropriate class (SH1 or SH2).

2 courses of 20 shots per each of 3 positions = 120.

ISSF Women 3 Position (Sport Rifle)

Unlimited sighting shots on sighting diagrams.

1 scoring diagram per record target, 2 shots per scoring diagram prone, 5 shots per scoring diagram standing & kneeling.

Squadding for relays will be random.

Men and Women 3 Position are fired simultaneously – total entry in the matches is limited to 35 positions.

Adaptive shooters will compete in their appropriate class (SH1 or SH2).

2 courses of 40 shots per each of 3 positions = 120.

ISSF Prone

Unlimited sighting shots on sighting diagrams.

1 scoring diagram per record target, 2 shots per scoring diagram.

Squadding for relays will be random.

Limit of 35 positions.

Adaptive shooters will be squadded on the Women's relay and will compete in their appropriate class (SH1 or SH2).

If by July 15, 2017, more entries than allowed for in the program are received then an additional relay may be scheduled.

The indicator for this will be determined following the close of the early entry deadline.

Note: If additional relays are warranted, notice will be provided as soon as possible.

2 courses of 60 shots per course = 120.

If the number of entries warrant, Men's Women's prone event will be shot concurrently on one line.

When dealing with crossfires on Gehmann targets, SFC rules will be applied. Confirmed crossfires will not be scored as misses but will be credited to the shooter with a penalty applied.

TEAM EVENTS

In ISSF there will be 3-person teams in each of the following:

ISSF Open and ISSF Junior Prone: mixed teams of men and women

ISSF Men 3 Position, Junior 3 Position, Women 3 Position, Junior 3 Position, Men Air Rifle, Junior Men Air Rifle, Women Air Rifle, Junior Women Air Rifle.

In Sporting Rifle there will 3-Person teams in each of the following:

Open Prone, International Junior Prone, Open 3 Position, International 3 Position.

In all team events Juniors can shoot on both the Open and Junior Teams if they have paid the adult fee.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

4.4 **Finals**

The national champion in each ISSF event will be determined by the results of the finals.

The Finals in the Air Rifle event will be shot using the 2017 ISSF rules.

The Finals in the ISSF Prone and 3-Position events will be shot using the 2017 ISSF rules with the following exception. All finalists will fire the complete number of shots as outlined in the ISSF rules, plus one extra shot to be used for tie breaking. Targets will be scored after the match, and results posted.

The top 8 Canadian Men Air Rifle shooters (including juniors) and the top 8 Canadian Women Air Rifle shooters (including juniors) will be invited to participate in the Finals, as determined by the main event.

The top 8 Canadian Men 3-Position shooters (including juniors) and the top 8 Canadian Women Sport Rifle shooters (including juniors) will be invited to participate in the Finals, as determined by the main event.

The top 8 Canadian Men Prone shooters (including juniors) will be invited to participate in the Finals, as determined by the main event.

Juniors must pay fees for the senior event to be eligible for the Finals.

4.5 **Dewar Match**

The top 20 Canadian men and women in ISSF Prone aggregate (Iron Sights, not including finals based on 2014 scores) will be invited to participate in the Dewar match. The match will consist of 20 shots at 50 meters and 20 shots at 100 yards. The Dewar match will use the standard ISSF 50 meter targets and will follow the new National Smallbore Rifle Association of Great Britain rules. There is no charge to compete in this event. This event will only take place if there enough participants and if so, the date will be posted during the course of the event.

4.6 **Awards**

There will be match and classification awards for both Men's and Women's events. Juniors may compete for both Classification and Junior awards by paying the adult fees. The number of entries per class will dictate the number of awards per class.

One or two shooters = one award

Three or four shooters = two awards

Five or greater shooters = three awards.

4.7 **Registration and Equipment Check**

Please fill out the online registration form. If you do not have internet access, a paper entry form is attached as Appendix 3.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

Registration and equipment check will be in the clubhouse located adjacent to the firing line, on the days and at the times noted in the Schedule of Events (Appendix B). All competitors are strongly urged to register on the days set aside for this purpose due to the tight schedule.

Registrations will be accepted the day prior to competition, except for Sporting Rifle, which will be accepted no later than 12:00pm on Friday, July 28th.

Competitor Numbers: Numbers will be supplied at registration. The competitor number is to be worn on the competitor's back above the waist. Numbers must be visible at all times while competing.

Changing Relays - The assignment of relays for all outdoor events will be carried out so that those competing in the same class will experience similar shooting conditions (time of day, wind, rain, lighting, etc.). Anyone requesting to shoot on a relay other than those on which he/she was originally assigned will not be eligible for awards.

4.8 Annual Section Meeting

The Annual Section Meeting will be held at the Monte Carlo Hotel starting at 3:00 pm on Tuesday, August 1st. All shooters and/or members should try to attend this meeting. If unable to attend the meeting, please submit any comments you would like to have read out at the meeting.

ARTICLE 5

PISTOL EVENTS

5.1 Match Information

Rules: Pistol events will be governed by the latest International Shooting Sport Federation (ISSF) rules wherever possible. **The match committee reserves the right to modify the rules, procedures and times dependent upon range conditions and local circumstances.**

Competitor Responsibility: It is the competitor's responsibility to be aware of the rules for competition, to have airguns, clothing and equipment inspected and approved before starting the competition, and to inform a range official immediately of any error or deviation from prescribed procedures.

Coaching: These events are individual in nature. **Coaching will not be permitted on the line,** but shooters may be assisted by coaches who will be allowed to communicate with them as permitted by the Range Officer. While shooting is in progress, competitors must always advise the Range Officer before leaving the line for any reason.

Equipment: Competitors must provide their own equipment which must comply with ISSF and/or SFC rules, as applicable. Equipment Control is not mandatory but it is recommended you go through in order to ensure all your equipment meets ISSF requirements as spot checks will be conducted on the line.

Protests: Filing and deciding of protests will be in accordance with ISSF rules and regulations. The fee is \$25 each.

Competitor Numbers: Numbers will be supplied at registration. The competitor number is to be worn on the competitor's back above the waist. Numbers must be visible at all times while competing.

Targets: Megalink targets are used on all positions.

Ties: Ties in individual events will be broken as per ISSF rules, and on the second course of fire. Ties in team events will be determined by the highest total score in the last 10-shot series fired by each shooter, working backwards by 10-shot series until the tie is broken.

5.2 Squadding

PRACTICE: Practice times will be limited; given the maximum use we intend to make of the range. Therefore, check the attached schedule closely and any updates that may be posted throughout the event. We may allow additional practice times after the days' events providing we have a Range Officer available.

- a. Squadding will be set initially with each registration.
- b. Changes in squadding may only be approved by the Match Jury. During the Championships, the organizing committee may charge a competitor \$25.00 for relay changes requested, unless an obvious conflict arises. Depending upon conditions, the request may or may not be granted.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

- c. A squadding list will be posted on the web site prior to the start of the event. This list may change before the match commences, and will be posted at the appropriate range.

5.3 Match Disciplines

All Events Are Open To SFC Members And Visitors

- a. All competitions are registered with the SFC.
- b. ISSF regulation 3.3.1.1, 3.3.1.2, 3.3.1.3, 3.3.1.4 and 2007 Section meeting determination, those competitions with team trials/finals are not open gender events. The following matches are restricted to males: 50m pistol, 25m Rapid Fire Pistol, 10m Pistol Men. The following matches are restricted to women: 25m Pistol and 10m Pistol Women.
- c. Match designation: and specifics of competition.

50m Pistol Men: *This competition will be shot under the following conditions at the PanAm Range: There will be 40 competitors per relay and 1 relay per day of assigned shooting.*

1. *Fired on the 50 m range.*
2. ***Megalink 50m electronic targets will be used:*** *The electronic scoring will scale all shots according to standardized reduction, if necessary or required.*
3. *60 shots in 1.5 hour time limit.*
4. *Competitors will fire **two** complete matches over two days. AWAD competitors will fire once over the course.*
5. *Sighting shots allowed in the time period assigned.*
6. *No more than 60 record shots in the competition.*
7. *No more than 1.5 hours of competition time unless unusual circumstances as determined by the CRO.*
8. *Awards: only Canadian citizens will advance to the finals.*
9. ***Current ISSF rules will apply.***

25 m Pistol Women: *This competition will be shot under the following conditions at the PanAm Range: There will be 32 competitors per relay and 1 relay per day of assigned shooting.*

1. *Fired on the 25 m range.*
2. ***Megalink electronic scoring will be used.***
3. *60 competition shots per competition.*
3. *Each competitor will fire **two** complete matches over two days. AWAD competitors will fire once over the course*
4. *In compliance with rule: 8.7.6.4 sub 5 all competitors will complete the precision stage before the rapid fire stage commences.*
5. *Awards: only Canadian citizens will advance to the finals.*
6. ***Current ISSF rules will apply.***

25 m Rapid Fire Men: *This competition will be shot under the following conditions at the PanAm Range: There will be 8 competitors per relay over 1 day of assigned shooting.*

1. *Fired on the 25 m range.*
2. ***Megalink electronic scoring will be used.***

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

3. 60 competition shots per competition to be completed in two halves of 30 shots per half course.
4. Each competitor will fire **two** complete matches over two days. AWAD competitors will fire once over the course
5. Awards: only Canadian citizens will advance to the finals.
6. **Current ISSF rules will apply.**

10 m Air Pistol: This competition will be shot under the following conditions at the PanAm Range: There will be 50 competitors per relay and 1 relay per day of assigned shooting.

1. Fired on the 10 m range.
2. **Megalink electronic targets will be used.**
3. 60 competition shot match for men.
4. 40 competition shot match for women.
5. Competition is open to male, female and junior competitors.
6. Competitors will fire **two** complete matches over two days. AWAD competitors will fire once over the course.
7. Sighting shots allowed in the time period assigned.
8. Finals will be completed for males, females, juniors and athletes with a disability.
9. Awards: only Canadian citizens will advance to the finals.
10. **Current ISSF rules will apply.**

25 m Standard Pistol: This competition will be shot under the following conditions at the Sharon Gun Club: There will be a maximum of 20 competitors per relay and 1 relay per day of assigned shooting.

1. Fired on the 25 m range.
2. This match will use paper targets with a buzzer for start and finish of each series.
3. 60 competition shots per competition
4. This is a gender open competition and SFC classes will be used.
5. Each competitor will fire **one** complete match over one day.
6. Awards: only Canadian citizens will be eligible for Canadian championship awards.
7. **Current ISSF rules will apply.**

25 m Centre Fire Pistol: This competition will be shot under the following conditions at the Sharon Gun Club: There will be a maximum of 20 competitors per relay and 1 relay per day of assigned shooting.

1. Fired on the 25 m range.
2. This match will use paper targets with a buzzer for start and finish of each series.
3. 60 competition shots per competition divided into 30 precision and 30 rapid fire.
4. In compliance with rule: 8.7.6.4 sub 5 all competitors will complete the precision stage before the rapid fire stage commences.
5. This is a gender open competition and SFC classes will be used.
6. Each competitor will fire **one** complete match over one day.
7. Awards: only Canadian citizens will be eligible for Canadian championship awards.
8. **Current ISSF rules will apply.**

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

5.4 Finals for Olympic Events

Final events will be conducted for all Olympic events for the 2017 Canadian National Championships. The Final Events will be fired according to the schedule attached.

5.5 Awards

All awards, other than Canadian Championship awards, will be standard medals. Team medals will differ from individual medals. Non-Canadian competitors will only be acknowledged as "High Visitor" in the competition results.

5.6 Annual Section Meeting

The Annual Section Meeting will be held at the Air Range starting at 2:00 pm on Saturday, July 29th. All shooters and/or members should try to attend this meeting. If unable to attend the meeting, please submit any comments you would like to have read out at the meeting.

ISSF DRESS CODE

ISSF Regulations Regarding the Clothing of Athletes, Coaches and Officials

6.7.6 ISSF Dress Code

It is the responsibility of athletes, coaches and officials to appear on the ranges dressed in a manner appropriate for a public sports event. Clothing worn by athletes and officials must comply with the ISSF Dress Code. See 6.19 for the full ISSF Dress Code.

6.7.6.1 If shorts are worn during competitions, the bottom of the leg must be not more than 15 cm above the center of the kneecap.

6.7.6.2 During competitions, athletes must wear shoes that comply with these Rules. Athletes may not wear sandals of any type or remove their shoes (with or without socks).

6.7.6.3 During Award or other Ceremonies, athletes are required to present themselves in their official national uniform or national training suits and sport shoes.

6.7.6.4 Juries are responsible for the enforcement of the ISSF Dress Code.

6.19 ISSF DRESS CODE

ISSF Regulations regarding the Clothing of Athletes, Coaches and Officials

ISSF Rule General Technical Rule 6.7.6 states:

"It is the responsibility of athletes, coaches and officials to appear on the range dressed in a manner appropriate for a public sports event. Clothing worn by athletes and officials must comply with the ISSF Dress Code. Copies are available from ISSF Headquarters."

This ISSF Rule is the basis for the ISSF Dress Code that is provided in this document.

6.19.1 GENERAL

All sports are concerned with the image they present to the public and media. Olympic sports, in particular, are judged by whether their athletes and officials present professional images and are a credit to their sports. Shooting's ability to grow as a sport and attract new participants and fans as well as shooting's future status in the Olympic movement are affected by how its athletes and officials appear to the public and media. The ISSF established the ISSF Dress Code to provide specific regulations and guidelines for the implementation of Rule 6.7.6.

6.19.2 DRESS REGULATIONS FOR ATHLETES

6.19.2.1 All clothing worn by athletes in Training, Elimination, Qualification and Final Round competitions must be clothing that is appropriate for wear by athletes in international-class sports competitions. This clothing must convey positive images of shooting athletes as Olympic sport athletes.

6.19.2.2 During award or other ceremonies, athletes are required to be dressed in their official national uniform or national training suits (tops and bottoms of training or warm-up uniforms including sport shoes). For teams, all members of the team must wear appropriate national uniforms (Rule 6.7.6.2).

6.19.2.3 Rifle athletes must comply with Rifle Clothing Regulations described in Rule 7.5. If they do not wear special shooting trousers or shoes, the clothing worn during competitions must comply with this ISSF Dress Code.

6.19.2.4 Pistol athletes must comply with Pistol Clothing Regulations described in Rule 8.5.

6.19.2.5 Shotgun athletes must comply with Shotgun Clothing Regulations described in Rule 9.12.1.

6.19.2.6 The intention of ISSF Rifle, Pistol and Shotgun clothing rules is that athletes in competitions must wear sports-type clothing that incorporates or displays national, NOC or National Federations colors and emblems. Appropriate clothing for wear during competitions includes training suits, tracksuits or warm-up uniforms, etc. as issued by National Federations or NOCs.

6.19.2.7 Prohibited clothing items for competitions and award ceremonies include blue jeans, jeans or similar trousers in non-sporting colors, camouflage clothing, sleeveless T-shirts, shorts that are too short (see Rule 6.7.6.1, not more than 15 cm above the center of the knee), ragged cut-off shorts, all types of sandals, trousers with patches or holes as well as shirts or trousers with non-sporting or inappropriate messages (See Rule 6.12.1, no propaganda). Sporting colors should be national uniform colors. If national colors are not worn, non-sporting colors that should be avoided are camouflage, plaids, khaki, olive or brown.

6.19.2.8 Changing clothes must be done in designated areas and not on the field of play (no changing on the firing points or in the ranges).

6.19.2.9 All clothing must comply with ISSF Commercial Rights, Sponsorship and Advertising Rules regarding the display of manufacturer and sponsor marks.

6.19.3 DRESS REGULATIONS FOR OFFICIALS

6.19.3.1 The ISSF Dress Code also applies to ISSF Jury Members and National Technical Officials including Range Officers and Shotgun Referees.

6.19.3.2 Competition officials must wear clothing that reflects the professional nature of their responsibilities. While they are on duty, Jury Members must wear the red Jury vests that are available from ISSF Headquarters. While they are on duty, Shotgun Referees must wear the blue Referee vests that are available from ISSF Headquarters.

6.19.3.3 Competition officials may not wear any prohibited clothing items that are described in paragraph 6.19.2.7 above.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

6.19.4 DRESS REGULATIONS FOR PHOTOGRAPHERS AND TV CAMERAMEN

6.19.4.1 Accredited photographers and TV cameramen with access to the field of play must respect the ISSF Dress Code because they are working in the public view.

6.19.4.2 Photographers and TV cameramen should not wear sleeveless shirts, cut-offs, gym or running shorts. If they wear shorts, they must wear socks and shoes.

6.19.4.3 Photographers working on the field of play must wear the official bib vest for POOL or NON-POOL PHOTOGRAPHERS that are issued by the ISSF. Photographer vests will bear the ISSF logo and may bear one sponsor logo not bigger than the ISSF logo. Photographer vests are numbered so photo coordinators or the ISSF Technical Delegate may identify photographers.

6.19.4.4 TV cameramen working on the field of play must wear the official bib vest for TV CAMERAMAN. These vests must bear the ISSF logo and have easily distinguishable numbers on the front and back of the bib vest so that TV cameramen can be identified.

6.19.4.5 Photographers and TV cameramen are not allowed to wear any other vest or jacket displaying advertising while working on the field of play.

6.19.5 ENFORCEMENT PROCEDURES

6.19.5.1 ISSF Equipment Control, Rifle, Pistol and Shotgun Juries are responsible for enforcing ISSF Clothing Regulations and the ISSF Dress Code (Rule 6.7.6.3)

6.19.5.2 During ISSF Championships, ISSF Juries will issue written warnings with requests to correct clothing violations for first violations. Athletes who receive written warnings and who do not correct clothing violations (change clothing) will be disqualified. Juries will normally give warnings during equipment inspection or training. Juries may allow an athlete to complete a Pre-Event Training series or stage (Shotgun or 25m Pistol) before changing if sufficient time to change is not available. No athlete will be permitted to participate in a Qualification or Final Round competition or in an awards ceremony while wearing inappropriate or prohibited clothing.

6.19.5.3 Before and during the competitions, Juries must use the ISSF Dress/Advertising Code Violation Warning Form (Form DC) to inform Dress or Advertising Code violators and to request corrective action.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

EXHIBIT II
ISSF CODE OF ETHICS

Article 3.12.3.5, Annex “CE”
ISSF Code of Ethics

PREAMBLE

In accordance with the ISSF Constitution, the objectives of the ISSF are to promote and encourage the development of the shooting sport throughout the world, to provide drug-free sport and to promote and encourage the development of international relations.

The purpose of this Code is to guarantee that the objectives of the ISSF will be executed in a fair manner, without improper interference, and to sanction incidents that damage the image of ISSF activities or bring them into disrepute.

ISSF members, continental organizations, teams, officials and athletes shall participate in ISSF Championships and activities in accordance with the standards of ethics, fair play and sportsmanship established by the ISSF Statutes, Rules and Regulations and by this Code. This Code provides basic standards for fair play and moral behaviour and procedures for judging and sanctioning violations of those standards.

With the following regulations the ISSF adopts its own code of ethics based on the principles and rules of the IOC Code of Ethics.

Furthermore, acknowledging the danger to sports integrity from the manipulation of sports competitions, ISSF restates its commitment to safeguarding the integrity of sport, including the protection of clean athletes and competitions as stated in the Olympic Agenda 2020. Therefore, ISSF with these regulations also implements the new IOC Olympic Movement Code on the Prevention of the Manipulation of Competitions. The Definitions used in version 2016 of such IOC Code also apply to the following rules.

For enforcement of this Code, the ISSF may establish an Ethics Committee.

1 SCOPE OF APPLICATION

1.1 SCOPE OF APPLICABILITY

This Code shall apply to conduct that damages the integrity and reputation of sports and in particular to illegal, immoral and unethical behaviour.

1.2 PERSONS COVERED

This Code shall apply to all officials and employees of the ISSF, ISSF member federations, the Continental Shooting Sport Confederations, as well as to athletes, coaches and other participants in ISSF activities.

1.3 APPLICABILITY IN TIME

This Code shall apply to conduct whenever it occurred including before the passing of the rules contained in this Code.

However, no individual shall be sanctioned for breaching this Code on account of an act or omission which would not have contravened the Code applicable at the time the breach was committed.

Neither may they be subjected to a sanction greater than the maximum sanction applicable at the time the breach occurred.

This shall, however, not prevent the Ethics Committee from considering the conduct in question and drawing any conclusions from it that are appropriate.

1.4 SCOPE OF THE CODE, CUSTOM, DOCTRINE AND JURISPRUDENCE

During all its operations, the Ethics Committee may draw on precedents and principles already established by sports doctrine and jurisprudence.

2 RULES OF CONDUCT

2.1 DUTIES

2.1.1 General Rules of conduct

Persons bound by this Code are expected to be aware of the importance of their duties and associated obligations and responsibilities.

Persons bound by this Code are obliged to respect all applicable laws and regulations, as well as ISSF Statutes, Rules and Regulations, and decisions taken by the competent ISSF bodies to the extent applicable to them.

Persons bound by this Code shall behave in a dignified manner and act with complete credibility and integrity. They shall respect universal fundamental ethical principles that include:

- a) Respect for the Olympic spirit, which requires mutual understanding with a spirit of friendship, solidarity and fair play;
- b) Respect for principles of universality, political neutrality and autonomy of the Olympic Movement;
- c) Respect for international conventions on protecting human rights insofar as they apply to the Olympic Games and ISSF Championship activities and which ensure in particular:
 - respect for human dignity;
 - rejection of discrimination of any kind on whatever grounds, be it race, color, sex, sexual orientation, language, religion, political or other opinion, national or social origin, property, birth or other status;
 - rejection of all forms of harassment, be it physical, professional or sexual, and any physical or mental injuries;
- d) ensuring the participants' conditions of safety, well-being and medical care favorable to their physical and mental equilibrium.

Persons bound by this Code may not abuse their position in any way, especially to take advantage of their position for personal or private aims or gains.

2.1.2 Duty of fair behavior / sportsmanlike behaviour

Persons bound by this Code are expected to behave in a fair way and shall in particular refrain from any form of cheating including, but not limited to doping, manipulation of equipment or scores to give an advantage to an athlete or to a team, falsification or alteration of documents indicating false age, nationality, gender or other information, with the purpose of obtaining unfair advantage for an official, an athlete or a team.

2.1.3 Loyalty

Persons bound by this Code have a duty of loyalty to the ISSF and its members. Therefore, they shall in particular refrain from any act of indiscretion, insubordination or partiality.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

2.1.4 Integrity of competitions

Persons bound by this Code shall not take part in, either directly or indirectly, or otherwise being associated with betting, gambling, lotteries and similar events or transactions connected with shooting competitions.

2.1.5 Other ethical offences

Other ethical offences, including the improper or illegal manipulation of equipment testing, ammunition testing, scoring decisions or competition results, illegal access to systems and data, committed by persons bound by this Code may be considered independent of any action taken or not taken by ISSF Competition Juries.

2.1.6 Forgery and falsification

Persons bound by this Code are forbidden from forging a document, falsifying an authentic document or using a forged or falsified document.

2.1.7 Duty of disclosure, cooperation and reporting

Persons bound by this Code shall immediately report any potential breach of this Code to the ISSF Secretary General or send an email to ethics@issf-sports.org.

At the request of the Ethics Committee, persons bound by this Code are obliged to contribute to clarifying the facts of the case or clarifying possible breaches and provide the evidence requested for inspection.

2.2 UNDUE ADVANTAGE

2.2.1 Conflicts of interest

When performing an activity for the ISSF, or before being elected or appointed, persons bound by this Code shall disclose any potential conflicts of interest that could be linked with their prospective activities.

Conflicts of interest arise if persons bound by this Code have, or appear to have, private or personal interests that detract from their ability to perform their duties with integrity and in an independent manner. Private or personal interests include gaining any possible advantage for the persons bound by this Code for themselves, members of their family, relatives, friends and acquaintances.

Any such conflict shall be immediately disclosed and notified to the body or organization for which the person bound by this Code performs his duties.

If an objection is made concerning an existing or potential conflict of interest of a person bound by this Code, it shall be reported immediately to the organization for which the person bound by this Code performs his duties for appropriate measures.

2.3 OFFERING AND ACCEPTING GIFTS AND OTHER BENEFITS

Persons bound by this Code may only offer or accept gifts or other benefits to and from persons within or outside ISSF, or in conjunction with intermediaries or related parties as defined in this Code, which

- a) have symbolic value;
- b) are not given to influence a decision, voting behaviour or any other act that is related to their official activities or that falls within their discretion;
- c) do not create any undue pecuniary or other advantage; and
- d) do not create a conflict of interest.

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

Any gifts or other benefits not meeting all of these criteria are prohibited. Requests for guidance should be addressed to the Secretary General.

2.4 BRIBERY AND CORRUPTION

Persons bound by this Code must not offer, promise, give or accept any undue pecuniary or other advantage for the execution or omission of an act that is related to their official activities. Such acts are prohibited, regardless of whether carried out directly or indirectly through, or in conjunction with, intermediaries or related parties as defined in this Code. Any such offer must be reported in writing to the Secretary General and any failure to do so shall be subject to sanctions in accordance with this Code.

Persons bound by this Code are prohibited from misappropriating ISSF assets, regardless of whether carried out directly or indirectly through, or in conjunction with, intermediaries or related parties, as defined in this Code.

2.5 NON-DISCRIMINATION

Persons bound by this Code may not offend the dignity or integrity of a country, private person or group of people through contemptuous, discriminatory or denigrating words or actions on account of race, skin color, ethnic, national or social origin, gender, language, religion, political opinion or any other opinion, wealth, birth or any other status, sexual orientation or for any other reason.

2.6 PROTECTION OF PHYSICAL AND MENTAL INTEGRITY

Persons bound by this Code shall respect the integrity of others involved. They shall ensure that the personal rights of every individual whom they contact and who is affected by their actions is protected, respected and safeguarded.

3 PREVENTION OF MANIPULATION

The following conduct as defined in this Article constitutes a violation of this Code:

3.1 BETTING

Betting in relation either:

- a) to a Competition in which the Participant is directly participating; or
- b) to the Participant's sport; or
- c) to any event of a multisport Competition in which he/she is a participant.

3.2 MANIPULATION OF SPORTS COMPETITIONS

An intentional arrangement, act or omission aimed at an improper alteration of the result or the course of a Competition in order to remove all or part of the unpredictable nature of the Competition with a view to obtaining an undue Benefit for oneself or for others.

3.3 CORRUPT CONDUCT

Providing, requesting, receiving, seeking, or accepting a Benefit related to the manipulation of a Competition or any other form of corruption.

3.4 INSIDE INFORMATION

- 3.4.1** Using Inside Information for the purposes of Betting, any form of manipulation of Competitions or any other corrupt purposes whether by the Participant or via another person and/or entity.
- 3.4.2** Disclosing Inside Information to any person and/or entity, with or without Benefit, where the Participant knew or should have known that such disclosure might lead to the information

being used for the purposes of Betting, any form of manipulation of competitions or any other corrupt purposes.

- 3.4.3** Giving and/or receiving a Benefit for the provision of Inside Information regardless of whether any Inside Information is actually provided.

3.5 FAILURE OF REPORT

Failing to report to ISSF or a relevant disclosure/reporting mechanism or authority, at the first available opportunity, full details of any approaches or invitations received by the Participant to engage in conduct or incidents that could amount to a violation of this Code.

Failing to report to ISSF or a relevant disclosure/reporting mechanism or authority, at the first available opportunity, full details of any incident, fact or matter that comes to the attention of the Participant (or of which they ought to have been reasonably aware) including approaches or invitations that have been received by another Participant to engage in conduct that could amount to a violation of this Code.

3.6 FAILURE TO COOPERATE

3.6.1 Failing to cooperate with any investigation carried out by ISSF in relation to a possible breach of this Code, including, without limitation, failing to provide accurately, completely and without undue delay any information and/or documentation and/or access or assistance requested by ISSF as part of such investigation.

3.6.2 Obstructing or delaying any investigation that may be carried out by ISSF in relation to a possible violation of this Code, including without limitation concealing, tampering with or destroying any documentation or other information that may be relevant to the investigation.

3.7 APPLICATION OF ARTICLES 3.1 to 3.6

3.7.1 For the determination of whether a violation has been committed, the following are not relevant:

- a) Whether or not the Participant is participating in the Competition concerned;
- b) The outcome of the Competition on which the Bet was made or intended to be made;
- c) Whether or not any Benefit or other consideration was actually given or received;
- d) The nature or outcome of the Bet;
- e) Whether or not the Participant's effort or performance in the Competition concerned were (or could be expected to be) affected by the acts or omission in question;
- f) Whether or not the result of the Competition concerned was (or could be expected to be) affected by the acts or omission in question;
- g) Whether or not the manipulation included a violation of any ISSF rule;

3.7.2 Any form of aid, abetment or attempt by a Participant that could culminate in a violation of this Code shall be treated as if a violation had been committed, whether or not such an act in fact resulted in a violation and/or whether that violation was committed deliberately or negligently.

4 DISCIPLINARY MEASURES, SANCTIONS

4.1 GENERAL

Breaches of this Code or any other ISSF Statutes, Rules and Regulations by persons bound by this Code are punishable by one or more of the following sanctions:

- a) warning;

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

- b) fine;
- c) return of awards;
- d) disqualification;
- e) suspension;
- f) expulsion;
- g) ban on entering a competition or a venue;
- e) ban on taking part in any shooting-related activity.

The Ethics Committee may decide that the notification of a case be made to the appropriate law enforcement authorities.

4.2 INVESTIGATIONS

The Participant who is alleged to have committed a violation of this Code must be informed of the alleged violations that have been committed, details of the alleged acts and/or omissions, and the range of possible sanctions.

4.3 BURDEN AND STANDARD OF PROOF

The ISSF shall have the burden of establishing that a violation has been committed. The standard of proof in all matters under this Code shall be the balance of probabilities, a standard that implies that on the preponderance of the evidence it is more likely than not that a breach of this Code has occurred.

4.4 CONFIDENTIALITY

The principle of confidentiality must be strictly respected by the ISSF during all the procedure; information should only be exchanged with entities on a need to know basis. Confidentiality must also be strictly respected by any person concerned by the procedure until there is public disclosure of the case.

4.5 DETERMINATION OF THE SANCTION

The sanction may be imposed by taking into account all relevant factors in the case, including the offender's assistance and cooperation, the motive, the circumstances and the degree of the offender's guilt.

The Ethics Committee shall decide the scope and duration of any sanction.

Sanctions may be limited to a geographical area or to one or more specific categories such as a competition.

Unless otherwise specified, the sanction may be increased as deemed appropriate if a breach has been repeated.

Where more than one breach has been committed, the sanction shall be based on the most serious breach, and increased as appropriate depending on the specific circumstances.

5 LIMITATION PERIOD

As a general rule, breaches of the provisions of this Code may no longer be prosecuted after a lapse of ten years.

The limitation period, when applicable, shall be prolonged if proceedings are opened and/or suspended.

6 PROCEDURES

Note: The Organizing Committee, in consultation with the match officials, reserves the right to alter the program and events as deem necessary.

6.1 ETHICS COMMITTEE

The ISSF Ethics Committee consists of the following persons:

- The President (acts as the Chairman of the Committee)
- One (1) Vice-President designated by the President
- The Secretary General
- The Chairman of the Judges Committee
- The Chairman of the Athletes Committee.

Members of the Ethics Committee must disclose to the Chairman any situation or fact that may establish a conflict of interest between themselves and the case under investigation. Such disclosure must be made immediately after the inquiry is opened or immediately after the situation or fact in question arises.

Any person being subject to investigations of a potential breach of this Code, or declare a conflict of interest, may not be part of the Ethics Committee. In such cases, or if a member of the Ethics Committee is unable to act, they must be replaced by a member of the ISSF Administrative Council appointed by the Executive Committee.

6.2 RULES FOR PROCEDURES

Any complaints, charges or guidance relating to a breach of ethical principles and rules should be addressed in writing to the Secretary General. The Secretary General shall inform the President in order to summon the Ethics Committee.

The Ethics Committee shall decide whether to conduct an inquiry or to dismiss the complaint.

When conducting an inquiry regarding a complaint or charges, the Ethics Committee may:

- Request written information or documents from the parties concerned;
- Hear the parties concerned, with or without the presence of legal counsel, as determined by the Ethics Committee;
- Decide to hear witnesses as determined by the Ethics Committee or at the request of the parties concerned;
- Conduct investigations in the field by designating one (1) or more of its members or another person to represent the Committee;
- Designate one (1) or more experts to assist the Ethics Committee in its inquiry.

In the absence of a consensus, decisions of the Ethics Committee shall be taken by majority of members present.

7 APPEALS

Decisions by the Ethics Committee may be appealed to the Court of Arbitration for Sport in Lausanne, Switzerland, ("CAS") which will resolve the dispute definitively in accordance with the Code of sports-related arbitration. The time limit for appeal is twenty-one days after the reception of the decision concerning the appeal.

8 MUTUAL RECOGNITION

Subject to the right of appeal, any decision in compliance with this Code by an International Sporting Organisation shall be recognised and respected by the ISSF.
